# A WORD FROM THE WEED CONTROL COMMITTEE:

The 2015 season will be the third year of exotic plant management on Pine Lake. In that time, we have observed significant declines in Eurasian watermilfoil on the lake, while maintaining good cover of beneficial native plant species. In 2012, prior to management, Eurasian watermilfoil was at 39.5% cumulative cover on the lake. Sonar A.S. was applied in the spring of 2013 with the goal of reducing milfoil levels throughout the lake. In September of that year, milfoil levels had dropped to .98% cumulative cover. In 2014, control was maintained and milfoil cumulative cover remained low at .83%. We have also seen an increase in the number of submerged native species observed. When milfoil was dominant, seventeen native species were found. In 2013, twenty were observed. In 2014, that number increased to a total of twenty three native species. This type of trend is fairly common when a significant reduction in Eurasian watermilfoil occurs. Native species that were crowded out will reestablish once released from competition.

While the program started with a whole lake treatment, management in 2013 and 2014 consisted primarily of monitoring and maintenance. The lake is evaluated 4-5 times during the year. If any new growth is found, it is addressed immediately on a spot treatment basis using the appropriate control option. The goal of this strategy is to slow/stop the spread of milfoil on the lake and to maintain control as long as possible. For 2015, the same treatment strategy will be used.

Despite management efforts, milfoil will most likely return to levels where another whole lake Sonar A.S. application may be required. Some lakes require Sonar A.S. every 3-4 years while others have gone 10 or more years without requiring it. We will do our best to maintain the control as long as possible. We are also looking for people interested in fire fighting. If you are interested in being a fire fighter, we will send you to a State of Michigan sanctioned Fire Fighter school. Upon successful completion of the classes you will be recognized throughout Michigan as Fire Fighter I and Fire Fighter II certified. We also pride ourselves on our continuing in-house training that includes controlled burn training, live burn training, and real structural fire fighting scenarios.

You do not have to do both. You can chose to be only a fire fighter, or only be a Medical First Responder, but we would love it if you chose to do both.

## 2015 Marine Law Changes

There are a couple of Marine Law changes as of April 16, 2015. Operating While Intoxicated on a boat law now mirrors that of the motor vehicle code. In a nut shell, the legal limit for Blood Alcohol Content (BAC) is .08 and this applies only to those operating a motor boat. In the past it included all vessels. Now it is worded "motor boat"- any watercraft with a motor, including a trolling motor. There will be zero tolerance for those having a BAC of .02 or higher if under 21 years of age and operating a motor boat...

We also want to remind folks that kids born after June 30, 1996 must have a boater safety card to operate any motorized vessel over 6 hp and anyone born after December 31, 1978 must have a boater safety card to operate a personal watercraft. I saw that the <u>boaterexam.com</u> website is offering half off for

one week only. The cost is normally 29.99 but if you register between April 20-26 then make a payment by May 8, you can get your card for 14.99. Of course anyone can use the site for free when you register however you will not get a card unless a payment is made.

## 10 Most Common Marine Law Violations 2015

All watercraft shall be equipped with a Coast Guard approved PERSONAL FLOTATION DEVICE (PFD) of appropriate size for each passenger. Boats over 16' are required to have a Coast Guard approved wearable for each person and one additional throw-able device. All PWC(Jet Ski) occupants are required to wear PFDs. Children under 6 must wear a Type I or II PFD while riding on an open deck of a vessel. Check the printed Coast Guard information on each jacket.

2. Vessels are required to operate at a slow, no wake speed, within 100 feet from any raft,

dock, occupied swim area, anchored or moored vessels, or persons in the water. The speed limit for an inland lake is 55 M.P.H. maximum and less for reduced visibility or congested areas.

3. Watercraft shall travel in a counterclockwise direction on the lake.

4. An operator of a vessel shall not be under the influence of alcohol or drugs.

5. Occupants of a vessel shall not sit or stand in an area not build to be stood or sat upon while the boat is under way ,i.e. seatbacks, decks, bow and gunwales.

6. Watercraft must have proper lighting from sunset to sunrise and during periods of restricted visibility.

7. A Personal Watercraft (PWC) may be operated during the hours between 8:00 AM until sunset.

8. Persons born after December 31, 1978 must have a Boaters Safety Certificate when operating a PWC. The minimum age for operating a PWC is 14 with a parent or 16 without a parent. To operate a (non-PWC) motorized boat over 6 H.P., the operator must be a minimum age of 12 with a boater's safety certificate. Those born after July 1, 1996 must carry a boater's safety certificate while operating any motorized vessel on Michigan waterways.

9. A PWC may not jump the wake of another non PWC watercraft within 150 feet of the boat's stern unless at a slow, no wake, speed.

10. Water skiing is legal 1 hour before sunrise until 1 hour after sunset. An observer other than the operator of the vessel is required.
